The State Advisory Committee, as per Section 88 of the Electricity Act, 2003, shall advise the Commission on:

- (i) Policy issues
- (ii) Matters related to quality, quantity and extent of service, provided by the Licensee
- (iii) Compliance by the Licensees with the conditions & requirements of their license
- (iv) Protection of consumer interests; &
- (v) Electricity supply & overall standards of performance by utilities

A consolidated sitting fee, of Rs. 500/-, shall be paid to the members, other than ex-officio members, for attending the meeting.

The other terms shall be as per RERC (State Advisory Committee) Regulations 2009.
