Eligibility criterion:

(1) The appointment on the post of Secretary shall be by reappointment of a serving or retired Indian Administrative Service (IAS) officer of Rajasthan cadre who is drawing or has last drawn pay in the pay scale of Rs. 37400-67000 (Grade pay Rs. 9500) or above or a serving or retired officer of Power Sector Companies/Electricity Regulatory Commission of Rajasthan who is drawing or has last drawn pay in the pay scale of Rs. 37400-67000 (Grade pay Rs. 9500) or above.

Remuneration & Conditions of Service:

- (i) The Pay and other allowance shall be as admissible to pensioners on reappointment as per Rajasthan Civil Services (Pension) Rules, 1996 as amended from time to time.
- (ii) The facility of stay in Government Guest House/Circuit House/Inspection Bungalow would be admissible as is applicable to Supertime Scale of IAS.
- (iii) Secretary would be entitled to casual leave/privilege leave and other leaves as admissible to the Supertime Scale of IAS.
