The Advisory Committee (vide Section 88 of the Electricity Act, 2003) shall advise the Commission on: -

- (i) Major questions of policy;
- (ii) Matters relating to quality, continuity and extent of service provided by the licensee;
- (iii) Compliance by Licensees with the conditions and requirements of their licence.
- (iv) Protection of consumer interest; &
- (v) Electricity supply & overall standards of performance by utilities.

The sitting fee of Rs. 500/- per person per day shall be paid to the members, other than ex-officio members for attending the meeting.

The actual reimbursement of to & fro traveling expenses by road or rail against submission of claim subject to a maximum of such allowance admissible to the Secretary of Government of Raj. , shall be paid to other than ex-officio members.
